

Sweeps Rules

Versatile Media and Marketing LLC, ("**Versatile Media and Marketing**") provides online games for the entertainment and enjoyment of its customers. To promote these services, Versatile Media and Marketing offers sweepstakes entries to be used to enter into sweepstakes contests that award prizes. These Sweeps Rules govern and control Versatile Media and Marketing's give away of sweepstakes entries and operation of promotional sweepstakes contests.

No purchase or payment necessary to participate. A purchase or payment of any kind will not increase a player's chances of winning. Games are void where prohibited by law.

Versatile Media and Marketing does not offer real money gaming, does not provide gambling services, and the Games are not meant to be used in relation to any gambling activity. All Games are offered free of charge and strictly for private entertainment and amusement purposes only. No Games or any information related to or resulting from the operation of any games may be used in any way for any gambling or wagering purposes, or for any other illegal or prohibited activity.

Versatile Media and Marketing offers two modes of gameplay: (1) Gold Coin Games, and (2) Sweepstakes Games (collectively, the "**Games**"). Gold Coin Games are provided solely for entertainment and amusement purposes only. Gold Coin Games do not offer prizes, and users are not eligible to receive any prize as a result of participation in Gold Coin Games. Users may receive prizes from participating in Sweepstakes Games, in accordance with the provisions set forth in these Sweeps Rules and Versatile Media and Marketing's Terms and Conditions, found at <https://www.Vegassweeps.com/terms> ("**Terms and Conditions**"). All capitalized terms undefined herein shall have the meaning provided to it in the Terms and Conditions.

Gold Coin Games are games played with "**Gold Coins**." Gold Coins may only be used in accordance with these Sweeps Rules and our Terms and Conditions, are provided solely for the purpose of participating in Gold Coin Games, have no real-world monetary value, and cannot be withdrawn, redeemed for prizes, cash, or any other form of currency.

Versatile Media and Marketing also gives away sweepstakes entries referred to as "**Sweeps Coins**." Sweeps Coins can be used to participate in Sweepstakes Games for a chance to win Sweeps Coins that are redeemable for real prizes and/or cash.

Your entry into a Sweepstakes Game constitutes your acceptance of these Sweeps Rules and any and all other terms and conditions relating to Versatile Media and Marketing's operation of its website <https://www.Vegassweeps.com/> (the "**Website**") and/or providing of services relating thereto, including, without limitation, our Terms and Conditions and Privacy Policy, found at <https://www.Vegassweeps.com/privacy>.

In the event you do not agree or wish to be bound by these Sweeps Rules, or our Terms and Conditions or Privacy Policy, your sole remedy shall be to not access Sweepstakes Games and/or to withdraw and discontinue your participation on the Website. You expressly agree and acknowledge that any and all dispute regarding your participation in a Sweepstakes Game shall be resolved in accordance with the provisions contained herein and/or the Terms and Conditions.

1. Eligibility

1.1. Sweepstakes Games are open only to legal residents of the Permitted Jurisdictions who are Registered Users with an active Account on the Website. All Sweepstakes Game Players must be at least twenty one (21) years old at time of entry. Entries will not be accepted from individuals under the age of twenty one (21) and any such entries are void. **“Permitted Jurisdictions”** means the United States, excluding the State of Connecticut, Delaware, Idaho, Michigan, Montana, and Washington and other states blocked to the players in the system from being accessed. **Participation is void where prohibited by law.**

1.2. A person who participates in a Sweepstakes Game is a **“Sweepstakes Game Player”**.

1.3. A person who participates in a Gold Coin Game is a **“Gold Coin Game Player.”**

1.4. Gold Coin Game Players and Sweepstakes Game Players are collectively referred to as **“Players.”**

1.5. Gold Coins and Sweeps Coins are collectively referred to as **“Coins.”**

1.6. Sweepstakes Games are subject to all applicable federal, state, and local laws and regulations. It is the sole responsibility of a Sweepstakes Game Player to determine whether participation in a Sweepstakes Game is legal and compliant with all regulations in the jurisdiction in which the Sweepstakes Game Player resides.

1.7. Employees (including, without limitation, part-time or temporary employees) of Versatile Media and Marketing , and any of Versatile Media and Marketing’s contest sponsors and their respective parent entities, subsidiaries, affiliated companies and advertising and promotion agencies, and the immediate family and other household members (i.e., spouses, parents, grandparents, children, grandchildren, roommates, housemates, significant others, partners, siblings (half and full) and the steps of each of the foregoing) of each of the above are NOT eligible to enter and/or to win Sweepstakes Games.

1.8. Participation in a Sweepstakes Games constitutes the Sweepstakes Game Player’s acceptance of these Sweeps Rules and Versatile Media and Marketing’s decisions, which are final and binding in all matters related to the Sweepstakes Games.

2. How to Enter

2.1. In order to enter a Sweepstakes Game, you must be a Registered User of the Website, have at least the minimum amount of Sweeps Coins in your account required for entry, and enter a Sweepstakes Game in accordance with these Sweeps Rules, subject to our Terms and Conditions.

2.2. To register for an Account, please visit the Website.

3. How To Collect Coins

3.1. You may collect Gold Coins in one of the following ways:

- a. **Registering an Account and “Daily Bonus” Giveaways.** Each Player will automatically receive a specific number of free Gold Coins upon registering an Account on the Website. Each Player will also receive a specific number of free Gold Coins whenever the Player logs into his/her Account and elects to claim his/her “daily bonus”. The specific number of

free Gold Coins provided may vary depending on the day, provided the amount thereof on each such day shall be clearly and conspicuously displayed on the Website. Each Registered User's ability to claim his/her "daily bonus" shall automatically reset on a twenty-four (24) basis.

- b. **Participation in Gold Coin Games.** Each Player may earn Gold Coins from participating in and/or winning Gold Coin Games.
- c. **Promotional Giveaways.** Each Player will have the right to receive free Gold Coins by participating in no-cost giveaways hosted by Versatile Media and Marketing and/or through social media platforms affiliated with Versatile Media and Marketing from time to time. Giveaways will be at no cost and the amount of Gold Coins given away will be stated for the applicable giveaway. The terms of any giveaway will be clearly and conspicuously displayed on the Website and/or third-party website affiliated with our offering of the giveaway/promotion. Gold Coins will be credited to each eligible Players' Account upon completion.

3.2. You may collect Sweeps Coins in one of the following ways:

- a. **Registering an Account and "Daily Bonus" Giveaways.** Each Player will automatically receive a specific number of free Sweeps Coins upon registering an account on the Website. Each Player will also automatically receive a specific number of free Sweeps Coins on a daily basis by logging on to his/her Account and elects to claim his/her "daily bonus". The specific number of free Sweeps Coins provided may vary depending on the day, provided the amount thereof on each such day shall be clearly and conspicuously displayed on the Website. Each Registered User's ability to claim his/her "daily bonus" shall automatically reset on a twenty-four (24) basis.
- b. **Bonus Item With the Purchase of Gold Coins.** Each Player will automatically receive Sweeps Coins as a free bonus when purchasing Gold Coins. The amount of Sweeps Coins a Player will receive as a bonus with purchase is stated on the Website. All purchases are final.
- c. **Promotional Giveaways.** Each Player will have the right to receive free Sweeps Coins by participating in no-cost giveaways hosted by Versatile Media and Marketing and/or through social media platforms affiliated with Versatile Media and Marketing from time to time. Giveaways will be at no cost and the amount of Sweeps Coins given away will be stated for the applicable giveaway. The terms of any giveaway will be clearly and conspicuously displayed on the Website and/or third party platform affiliated with our offering of the giveaway/promotion, including, without limitation: (i) the period of the giveaway, (ii) the amount of Sweeps Coins to be provided per the giveaway, and (iii) any other additional terms and conditions specifically relating to Versatile Media and Marketing's and/or another sponsor's offering of the giveaway. Sweeps Coins will be credited to each eligible Players account upon completion. From time to time, Versatile Media and Marketing may also make Sweeps Coins available at no cost for additional promotions, which can be modified or discontinued at the sole discretion of Versatile Media and Marketing.
- d. **Mail-in Request.** Sweeps Coins can be obtained by mailing Versatile Media and Marketing via U.S. Mail, first class, postage prepaid, a handwritten postcard or letter request with your name, full address, and account information, with subject "Free Sweepstakes Entry," to Versatile Media and Marketing LLC. 8 The Green Ste 300 Dover, DE, 19901.

There is no limit to the number of requests that can be made but each request must be made on a separate postcard or letter. Sweeps Coin(s) will be provided in response to the mailed request.

3.3. The amount of Coins a Player has will be displayed in his/her Account on the Website. Versatile Media and Marketing reserves the right to change the amount of Coins allocated to Players in accordance with Versatile Media and Marketing's Terms and Conditions.

3.4. All Sweeps Coins awarded without purchase have the same chance of winning all prizes as Sweeps Coins awarded in connection with the purchase of a product or service. You cannot purchase Sweeps Coins, and Sweeps Coins have no monetary value. Neither Sweeps Coins nor Gold Coins may be sold, transferred, assigned, gifted, traded or sublicensed (including for monetary exchange or for any other value). Sweeps Coins received via any of the methods described above cannot be redeemed or exchanged for any item of value. Only Sweeps Coins won from participating in a Sweepstakes Game may be exchanged or redeemed, subject to the Website's Terms and Conditions and these Sweeps Rules. You acknowledge that Sweeps Coins received with purchase of Gold Coins (or received via the other methods described herein) constitute intangible digital items of no value that are being provided incidental to and in connection with Versatile Media and Marketing's promotion of the Website, including, but not limited to, your participation in Gold Coin Games.

3.5. Use of any automated or other system(s) to acquire Coins or play the Games is prohibited and will result in disqualification and loss of eligibility to participate in the Games. Coins may be forfeited if a Player's account is deactivated for any reason, including, without limitation, violation of these Sweeps Rules and/or Terms and Conditions.

3.6. Sweeps Coins not played for 60 days following placement into your account are deemed forfeited at the sole discretion of Versatile Media and Marketing. Sweeps Coins and/or Gold Coins may be forfeited if a Player's Account is terminated for any reason, including, without limitation, violation of these Sweeps Rules and/or our Terms and Conditions.

4. Playing Sweepstakes Games

4.1. Versatile Media and Marketing reserves the right to offer various Sweepstakes Games as determined in its sole discretion. The amount of Sweeps Coins required to play any Sweepstakes Game and the Prizes (including, but not limited to, amount of Sweeps Coins) earned from playing such Sweepstakes Game will be made known to each Sweepstakes Game Player prior to the beginning of the Sweepstakes Game.

4.2. Only Sweeps Coins that have been won following the completion of a Sweepstakes Game can be redeemed for Prizes.

4.3. All Versatile Media and Marketing's decisions regarding the operation of a Sweepstakes Game shall be final and binding.

4.4. Versatile Media and Marketing reserves the right to modify, alter, or change the rules, regulations, and prize amounts of any Sweepstakes Game at any time in its sole discretion. All changes shall be made known on the Website prior to the beginning of a Sweepstakes Game. Each Sweepstakes Game Player acknowledges that he/she shall be responsible for staying up to date with any and all changes made to Versatile Media and Marketing's operation of Sweepstakes Games. In the event of modifying

a Sweepstakes Game, a Sweepstakes Game Player's continued participation in the Sweepstakes Game constitutes acceptance of the modified terms.

4.5 Unless Versatile Media and Marketing requires otherwise, any Sweeps Coins allocated to a Player are required to be played once before they are eligible to be redeemed for prizes. Versatile Media and Marketing may, in its sole discretion, require that any Sweeps Coins allocated to a Player must be played a greater number of times in any combination of Sweepstakes Games before they are eligible to be redeemed for prizes.

4.6 The odds of winning each Sweepstakes Game can be found within the game rules associated with such Sweepstakes Game. A purchase will not increase any Player's chances of winning any Sweepstakes Game.

4.7 Promotional Period: Sweepstakes Games are offered on the Website concurrently with Versatile Media and Marketing's offering of Gold Coin Games. Versatile Media and Marketing's servers are the official time-keeping device for all promotions run via Versatile Media and Marketing's offering of Sweepstakes Games. Each promotional period runs from the start of January 1 to the end of December 31 for any given year ("**Promotional Period**"); provided, Versatile Media and Marketing reserves the right to: (i) cancel any Promotional Period and/or any Sweepstakes Games offered during such period in accordance with these Sweeps Rules and/or our Terms and Conditions, and/or (ii) discontinue its offering of Sweepstakes Games following the conclusion of any Promotional Period, as determined in Versatile Media and Marketing's sole discretion

5. Winner Notification

5.1. All winners will be notified by private message and/or by email associated with their Account. No Sweepstakes Game Player may be allowed to redeem any winnings for prizes until such Sweepstakes Game Player's eligibility has been verified by Versatile Media and Marketing. Versatile Media and Marketing reserves the right to seek additional verification of eligibility or identity prior to awarding prizes for winning entries at its sole discretion. All decisions regarding verification of eligibility are final and binding.

5.2. Potential winners must comply with these Sweeps Rules and Terms and Conditions and winning is contingent upon fulfilling all requirements made known by Versatile Media and Marketing.

5.3. The ability to redeem Sweeps Coins won from participation in a Sweepstakes Game may be forfeited if a potential winner cannot be contacted, fails to comply with Versatile Media and Marketing's verification requests within the required time period, fails to comply with these Sweeps Rules or Terms and Conditions, or if the prize or prize notification is returned as undeliverable. In the event that a potential winner of a Sweepstakes Game is disqualified or ruled ineligible for any reason, such prize shall be deemed forfeited.

6. Prize Redemption

6.1. All redemptions of Sweeps Coins won from participation in a Sweepstakes Game will be paid out in USD using a third party payment provider authorized by Versatile Media and Marketing.

6.2. We reserve the right to limit the amount of the minimum or maximum redemption value for any prize per day as we deem fit in our sole discretion. In New York and Florida, the maximum redemption value for a prize won from any one Sweepstakes Game is USD \$5,000 and any prize with a value in excess of USD \$5,000 will be reduced to a maximum value of USD \$5,000.

6.3. By claiming any prize the winner certifies eligibility and compliance with these Sweeps Rules and acceptance constitutes such winner's agreement to release and to hold harmless Versatile Media and Marketing, and its affiliates, subsidiaries, advertisers, and agencies from any liability arising out of participation in any Sweepstakes Game. The prize winner is responsible for all applicable taxes. All prize winners and prizes will be reported to governmental tax authorities as required by law. Versatile Media and Marketing reserves the right to verify the eligibility of all potential prize winners to participate in Sweepstakes Games and/or redeem a Prize prior to the delivery and/or any redemption thereof. If you fail to provide the requested information needed for Versatile Media and Marketing to verify your eligibility to participate in a Sweepstake Game and/or win a Prize, or if we determine that you have violated these Sweeps Rules, our Terms and Conditions, and/or any other rules specific to the applicable Sweepstakes Game, the Prize may be forfeited and/or we may suspend or terminate your Account.

6.4. No substitution or transfer of prize is permitted. Versatile Media and Marketing reserves the right to substitute the listed prize with another prize of equal or greater value for any reason owing to circumstances outside Versatile Media and Marketing's reasonable control.

7. Publicity

By participating in a Sweepstakes Game, each Sweepstakes Game Player consents to the use of his/her name, voices, pictures, images, or other likeness for advertising, promotional and other purposes as determined by Versatile Media and Marketing without further approval or compensation, worldwide, in perpetuity and in any and all forms of media, whether now known or hereafter devised (except where prohibited).

8. Disqualification

Versatile Media and Marketing reserves the right, at its sole discretion, to disqualify any individual it finds to be tampering with the entry process, the operation of a Sweepstakes Game, the Website, or to be acting in violation of these Sweeps Rules or our Terms and Conditions. Versatile Media and Marketing shall be the sole arbiter in all matters relating to Sweepstakes Games and the interpretation of these Sweeps Rules. Entry into a Sweepstakes Game constitutes agreement by all entrants to abide by these Sweeps Rules, our Terms and Conditions, as well as any other rules established by Versatile Media and Marketing.

9. Limitations Of Liability And Release

9.1. By entering into a Sweepstakes Game, all Sweepstakes Game Players agree to release, indemnify, and hold harmless Versatile Media and Marketing, and its respective parents, subsidiaries, affiliates, distributors, sponsors, contractors, suppliers and advertising, promotional and judging organizations and each of their respective employees, officers, directors, shareholders and agents (collectively, the "**Releasees**") from and against any and all claims, expenses, and liability, including but not limited to negligence and damages of any kind to persons and property, including but not limited to invasion of privacy (under appropriation, intrusion, public disclosure of private facts, false light in the public eye or other legal theory), defamation, slander, libel, violation of right of publicity, infringement of trademark, copyright or other intellectual property rights, property damage, or death or personal injury sustained in connection with receipt, ownership, use, or misuse of a prize, or while preparing for or participating in any qualifying or prize-related activity, or in any other way related to participation in the Sweepstakes Game.

9.2. By entering into a Sweepstakes Game, all Sweepstakes Game Players agree to indemnify, defend and hold harmless Versatile Media and Marketing and its Releasees from and against any and all claims, expenses, and liabilities (including reasonable attorneys/legal fees) arising out of or relating to a Sweepstakes Game Player's participation in the Sweepstakes Game and/or Sweepstakes Game Player's acceptance, use or misuse of prizes.

9.3. Versatile Media and Marketing and the Releasees are not responsible for any incorrect or inaccurate information, whether caused by Website users, Sweepstakes Game Players, or by any of the equipment or programming associated with or utilized in the Sweepstakes Games and assume no responsibility for (i) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from a Sweepstakes Game Player's participation in a Sweepstakes Game or receipt or use or misuse of any Prize (ii) any error, omission, interruption, deletion, defect, or delay in operation or transmission on the Website, (iii) any computer, telephone, cable, satellite, network, electronic or Internet hardware or software malfunctions or failures, problems with connections or availability, (iv) garbled or jumbled transmissions, service provider/Internet/web site/use net accessibility or availability, (v) traffic congestion, (vi) unauthorized human intervention, or (vii) theft or destruction, tampering, or unauthorized access to entries and/or entry information. If, for any reason, a Sweepstakes Game is not capable of running as planned by reason of infection by computer virus, tampering, unauthorized intervention, fraud, tampering, technical failures, or any other causes beyond Versatile Media and Marketing and/or the Releasees control, Versatile Media and Marketing reserves the right, at its sole discretion, to cancel, terminate, modify or suspend such Sweepstakes Game and/or select the winner(s) from among all eligible entries received for that Sweepstakes Game prior to the action taken.

IN NO EVENT WILL VERSATILE MEDIA AND MARKETING OR THE RELEASEES BE RESPONSIBLE OR LIABLE FOR ANY DAMAGES OR LOSSES OF ANY KIND, INCLUDING INDIRECT, INCIDENTAL, CONSEQUENTIAL OR PUNITIVE DAMAGES, OTHER THAN A PLAYER'S ACTUAL OUT-OF-POCKET EXPENSES ARISING OUT OF YOUR PARTICIPATION IN A GAME. WITHOUT LIMITING THE FOREGOING, PREMIUM GAMES ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESSED OR IMPLIED, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR NON-INFRINGEMENT. SOME JURISDICTIONS MAY NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES OR EXCLUSION OF IMPLIED WARRANTIES SO SOME OF THE ABOVE LIMITATIONS OR EXCLUSIONS MAY NOT APPLY TO YOU. CHECK YOUR LOCAL LAWS FOR ANY RESTRICTIONS OR LIMITATIONS REGARDING THESE LIMITATIONS OR EXCLUSIONS.

10. Dispute Resolution

All disputes regarding these Sweeps Rules and/or your participation in any Sweepstakes Game shall be governed in accordance with the terms of the "Dispute Resolution and Arbitration Agreement," set forth in the Terms and Conditions. Damages are limited to a refund of any money spent purchasing the product or service of Versatile Media and Marketing for which the Sweeps Coins were awarded, if any.

11. Miscellaneous

11.1. These Sweeps Rules shall be governed by the internal substantive laws of the States without respect to its conflict of laws principles.

11.2. Nothing in these Sweeps Rules shall create or confer any rights or other benefits in favor of any third party except as expressly provided herein.

11.4. All information collected from a Sweepstakes Game Player shall be subject to the terms set forth in Versatile Media and Marketing's Privacy Policy. Except as set forth herein, our Terms and Conditions shall govern all other provisions relating to your participation in the Games and/or use of the Website.

11.5 Versatile Media and Marketing reserves the right to cancel, suspend and/or modify the Sweepstakes Games, with immediate effect, for any reason, including, without limitation, owing to circumstances outside its reasonable control, as determined by Versatile Media and Marketing in its sole discretion.

11.6 Versatile Media and Marketing reserves the right to update, modify, or otherwise amend these Sweeps Rules without prior notice, and such changes shall go into effect as of the "Last Updated" date provided above. Your continued participation in the Games shall constitute your acceptance of any and all changes to these Sweeps Rules. If you do not agree to any changes set forth in these Sweeps Rules, then you should not continue to participate in any Games or otherwise access the Website.

11.7 Any failure by Versatile Media and Marketing to enforce any provision contained in these Sweeps Rules shall not constitute a waiver thereof.
